Law and Economics

The Importance of a New Interdisciplinary Study Track in Law and Economics

The interdisciplinary study track in Law and Economics corresponds with the actual and worldwide trend that the lawyers of today increasingly face economic issues in their practical work. Legal factors also constitute important basic parameters of management decisions. Legal consulting and legal representation have to a considerable extent acquired a strategic character. This development explains the need for specialists who apart from legal knowledge have a wide understanding of economic processes which they can also apply in an interdisciplinary manner.

Bachelor of Arts HSG (B.A. HSG) in Law and Economics (180 Credits)

The primary aim of the Bachelor's course is to obtain a solid basic legal knowledge. The curriculum provides for comprehensive courses in private and public law. The study program "B.A. HSG in Law and Economics" covers the majority of the courses of the conventional Bachelor's program in law at the University of St.Gallen. In addition, the study program "B.A. HSG in Law and Economics" includes core courses in business administration and economics.

Law and Economics

The graduates of our study programs in law and economics are lawyers who are capable of an integrative administration and management of problems in the fields of law and economics. A main focus of the training lies in the procurement of the relevant methodological skills. The law students are thus thoroughly acquainted with the tools of economics. The target is to obtain a high competence of being able to take part in the discussion on the management and strategy of companies, in which the business lawyer not only shall include the economic and legal calculus but also an acquired range of values deriving from both disciplines. The study programs are taught in German.

Master of Arts HSG (M.A. HSG) in Law and Economics (120 Credits)

The Master's program in Law and Economics (MLE) enables a novel interdisciplinary education which prepares the students for practical work at the interface between law and economics. Built upon the wide spectrum of the Bachelor education the knowledge of law and economics will be deepened and increasingly combined to a network. The training of an integrated way of thinking will take place within the framework of integrative seminars, which have a genuine interdisciplinary character and are held by scholars of different disciplines. The MLE program, with its balanced emphasis on legal training, offers a solid foundation in law and enables the unrestricted admission to the bar examination in Switzerland.

Due to their knowledge in law and economics, the graduates are capable of identifying complex problems in state administration and companies, making such problems comprehensible and developing an integrated approach to their resolution.
